

#### 4. POWER:

- I. In pursuance of the foregoing objectives of the founder trustee is hereby empowered.   - V. To permit any agents or any other persons authorized by the TRUST to use and occupy any building, erections or other property of the trust on such terms and conditions as the trust may deem fit.
- VI. The funds of the institution would be invested as per section 11(5) of the I.T. Act, 1961.
- VII. The accounts would be maintained regularly and would be audited by a Chartered Accountants. The funds of the trust would be utilized only towards the objects and no portion of it would be distributed in any manner to the trustees or persons defined in section 13(1)(C) of the I.T. Act, 1961.
- VIII. In the case of winding up/dissolution of trust/society, the net funds /assets would be transferred to trust society having similar objects and enjoying exemption u/s 12A and approval u/s 80G.
  - IX. The benefits of the objects of the trust/society would be available to the general public irrespective of caste, creed, religion or sex.
  - X. Any amendment to the trust deed Rules and Regulations of the Trust would be carried out only with the prior approval of the Commissioner of Income Tax.
  - XI. The funds and the income of the trust shall be solely utilized towards the achievement of the objectives and no portion of it shall be utilized for payment to trustee by way of profit, interest, dividends etc.,
  - XII. To appoint the trustees to the management trustees who shall have the responsibility for the general administration of the trust.

- XIII. To act as agents for any person body, society or undertaking in any matter and in any lawful manner for the furtherance of the above objects of the TRUST.
- XIV. To do all such other things as are necessary for the attainment of the above objects or any of them.
- XV. The funds and the income of the trust shall be solely utilized towards the achievement of the objects and no portion of it shall be utilized for payment to trustees by way of profit, interest, dividends.
- XVI. The funds/ fees/ scholarship shall be collected in the name of the trust or its nominees/ governing body and shall be accounted to the trust.
- XVII. To consider the termination of any trustees/ trustees(except founder trustees & life trustees) who acts against the interest of the trust and also remove any trust/ trustees without assigning any reason by majority decision of the management trustees.
- XVIII. To lay down general polices for the furtherance of the aims and objects of the trust.
  - XIX. To appoint committees or sub-committees, patrons advisory council. general or special purpose for the efficient running of the trust.
  - XX. Do delegate such of its powers to such trustees as the management trustees of the trust may decide.
  - XXI. To appoint the trustees to the management trustees who shall have the responsibility for the general administration of the trust.

#### 5. MANAGEMENT:

- a) The board of Trustees shall comprise of a minimum of 2 Trustees, the vacancies on the board of Trustees shall be filled in by the managing trustee in his discretion for such term as stipulated at the time of their appointment. - a) The management trustees shall have power to constitute/appoint governing body/Executive body/committee/sub committee to run, maintain the activities of the intuition/collage/hospital/religious centers mentioned in the aims and objects of the trust which overall supervision/guidance/control of the management trustees.
- b) The management trustees shall form rules and regulations for each subcommittee/committee/governing body and clearly state their duties, powers and responsibilities.

#### 6. THE TRUST:

The trust property is to be used for the furtherance of the activities as aforementioned and scalable or purchase rights belongs to the founder trustee.

#### 7. MANAGING TRUSTEE:

The Managing Trustee shall have the following powers:

- 1. The managing trustee shall have the powers to administer the funds of the Trusts as per power delegated by the Board of Trustees.
- 2. The Managing Trustee shall have overall powers of superintendence over the affair of the trust and shall have in particular the power to operate the bank account(s) of the trust along with any other trustee or person as decided in the meeting by the board of Trustees.

- 9. The Managing Trustee shall disburse funds of the trust and the institutions of the trusts as per sanction and approval of the Board of Trustees.
- 10. The Managing Trustee shall get account audited by an auditor appointed by the Board of trustees and submit the report to the Board of Trustees for approval.
- 11. The Managing Trustee shall be responsible to monitor the affairs and functioning of the trust and to keep a vigil and watch to make sure that the aims and objects are achieved.
- 12. The First Managing Trustee may appoint from time to time as he deems fit any trustee to be the joint Managing Trustee to work on his instructions for such a terms decided by him and to delegate some or all of his powers and duties as he feels necessary.

#### 8. THE TRUSTEES:

- 1. The Managing Trustee: one among the founder trustee shall be the management trustee and shall be appointed from among the one founder trustees within seven days of registration. First three founder trustees are appointed as permanent trustees/life time trustees. All the other are liable to retire by rotation every two years and they are eligible for re election.
- 2. The number of the trustees of the trust shall not at any time be less than two and when there is only on trustee additional trustees shall forthwith be appointed provided nevertheless that the number of the trustees shall not at any time exceed nine.
- 3. Any of the trustee may retire from the trust hereof by notifying his/her fellow trustee in writing of his/her intension so to do and from the date of receipt of such notification the retring trustee shall be discharged from the trust hereof.
- 4. If any one of the trustees dies or become bankrupt, insolvent or mentally incapacitated or in the judgment or majority of the other trustees signified by them in writing under their respective hands conduct himself in a manner unbecoming of a trustee such trustee shall cease to be a trustee of this trust.
- 5. No person shall be appointed as trustee who under the preceding clause would be lawfully unable to continue to be a trustee.

## 9. BANK ACCOUNTS:

Bank accounts of the trust shall be opened and operated in the name of the TRUST by founder trustee/Chairman along with trustee.

# 10. THE ACCOUNT:

Account shall be maintained all accounts of the Trust regularly. The accounts shall be audited by a chartered accountant every year. Accounts shall be closed every year by 31st of March.

# 11. MEETINGS OF THE TRUSTEES:

Meetings of the trustees shall be called by the managing trustee with the consultation of trustees when the affairs of the trust so demand but at least once in every year, such annual meetings being know as the Annual General Meetings of the trust.

12. A circular resolution issued by the management trustee in consultation with the President on any subject and signed by a majority of the trustees, shall in all respects, be valid and binding as a resolution passed at a meeting of the trustees duly convened and constituted and such resolution shall not be deemed invalid by reason of want of notice or any others cause whatsoever.

#### 13. QUORUM & VOTING:

One third of the total trustees with the minimum of two office bearers present in the meeting shall from quorum of meeting of trustees. All proceedings and questions and matters arising at the meeting of the trustees shall be decided by the majority of votes and incase of equality of vote chairman shall have a second or casting vote provided.

#### 14. DECISION OF THE TRUSTEES:

Except where otherwise provided any question arising as to the property or shall be conclusively settled as between all parties concerned by decision of majority of the number of management trustees for the time being.

#### 15. PREVILIEGES OF TRUSTEES:

- a) As per the trust deed the founder of trustees and other trustees may be paid actually incurred expenses, remunerations, salary, honorarium, pocket expenses for the work done on behalf of the trust.
- b) Any trustee of the trust who causes loss, damage etc., to any property of the trust through his/her willful default for neglect shall reimburse to the trust.
- c) The liability of the trustees if the trust shall be limited to the assets of the trust.

#### 16. THE PROPERTY OF THE TRUST:

The trust fund now vested in the trustees and any other funds, property hereafter entrusted to the trustees for the time being or any one or more of them by gift or any means shall from the date of such funds becoming so vested be held any administered by the trustees for the time being in accordance with the terms of the deed.

#### 17. LEGAL PROCEEDINGS:

The Founder has authority solely to institute all actions and proceedings in the name and on behalf of the trust and the Trustees and also to defend them in respect of all matters touching the trust, its institutions, funds and properties. It shall not be necessary to join the other trustee in such actions or proceedings.

#### 18. INDEMINITY:

Every trustee shall be indemnified out of the trust fund against all losses and expenses incurred in the discharge of his duties expect such as shall happen through his own negligence willful act or default and each trustee shall be chargeable with only such money or property as he or they shall actually receive for or in the discharge of the affairs of the

trust and each shall be answerable only for his own acts, neglects or defaults and not for those for any other person.

## 18. THE TRUST FORMED IS IRREVOCABLE:

### 20. VARIATION OF THE TERMS OF TRUST:

Alteration to the clauses of the deed shall only be made at a meeting of the trustee after giving notice of one calendar month which notice shall be accompanied by details of the proposed alteration and shall be subject to confirmation at a second meeting of the trust held not earlier than one calendar month after the first , meeting.

Clause may be altered by the votes of two-third of the number of the trustees with the prior permission of the commissioner of the Income Tax /Director of income Tax (Exemption) all alterations shall be confirmed by a deed of variation of trust. No amendments to the trust deed shall be made which may prove to be repugnant to the provision of the section 2(15),11,12,13, 80G of the income tax act, 1961.

#### 21. INTERPRETATION

The Trust Deed and the rules and regulation of the trust shall be interpreted by the board of Trustee and their decisions shall be final and binding.

# 22. DISSOLUTION AND DISTRIBUTING OF ASSETS:

If at any time the continuation of the trust shall appear to two-third of the trustees for the time being not to serve any useful purpose the trust shall for the wish be windup and any assets remaining after the satisfaction of all lawful liabilities and claims against the trust the same under no circumstances be paid to do distributed among the trustees, for the time being or former trustees or made available for personal benefit of anyone but shall be given to some other Registered Society, Trust, Association or intuition or non-profit company (whose objective are similar to those of this trust and which enjoys registration as per provision of Income Tax Act 1961) to be determined by two-third of the trustees for the time being or in default thereof by the court of law having jurisdiction in the matter.


